



## PROGRAM CONTENT

**Religious Organizations** The names of religious organizations, churches, denominations, or individual leaders, with whom our policies preclude association and cooperation, must not be mentioned over the air in a derogatory way. It is not our privilege in the public medium of radio to degrade any other religious organization that disagrees with our doctrine, practice, or policies. However, it is our responsibility to our audience to expose false and unbiblical doctrines. Such false doctrines can be carefully explained and then exposed Scripturally - in a kind manner. True biblical doctrine in contrast with false doctrine can be presented at the same time without derogatory statements.

**Political Issues** Care must be maintained at all times to avoid involvement in partisan debate or controversy over any political issues. Neither should any derogatory references ever be made against any legal government of any country nor against any government official in particular.

**Cultural Issues** In every culture there are some customs that are good and some that are bad, according to Biblical principles. This station will promote good West Indian cultural practices and characteristics. However, we cannot - in any way - lend approval or promote any cultural practices and characteristics that must be judged as wrong or harmful by the Scriptures.

**Money Appeals** No money appeals of any kind may be broadcast in any of the station's programming from any source. Each broadcaster will be expected to support their own program ministry without appealing to the general public for help. If mentioned at all, a

statement to the effect that yours is "a faith ministry dependent on the gifts of the Lord's people" is the most that should be said. Broadcasters will be permitted to offer literature, tracts, booklets, cassette tapes, etc. to listeners who will write and request them, as long as this offer is not tied to an appeal for support. Offers will encourage response from listeners and can afford opportunities for further spiritual help. Please remember, this is a ministry! If your program is of the Lord, you have already been promised full support - Phil 4:19. Don't ask the listeners(people), ask your Heavenly Father!

**Local Announcements** Non-local broadcasters should avoid the use of announcements or information of interest only to their local church etc. Listeners could mentally "turn you off" or, worse, change stations rather than listen through information that may be out of date and/or has no meaning to them. We welcome local church announcements from our Caribbean broadcasters, but be sure these will not be outdated by the time the programs are aired.

**The "versions" Issue** Since the Scripture itself does not identify the specific physical means of its preservation; and since it is evident from history that God has delighted to preserve His Word in a variety of ways - in the thousands of manuscripts extant today and in a succession of English translations (as well as other languages); and since God could, if He so chose, preserve His word in a continuing succession of translations; and since there are many good and godly men on both sides of the preservation/translation issue, the Harbour Light of the Windwards will not allow derogatory, sarcastic or disparaging remarks

about any version or position on this issue. We stand where the King James translators themselves stood in their day concerning translations. They said "we do not deny, nay we affirm and avow, that the very meanest translation of the Bible in English, set forth by men of our profession, containeth the word of God, nay, is the word of God." ## PROGRAM PRODUCTION

**Recording Material** We are able to use reel-to-reel tapes, cassettes, & CDs (mp3 or standard). If using cassettes, please use high quality cassette tapes. We prefer CDs or you may consider delivering your program via our FTP server. Alternately, we could download your programs if you are set up for that.

**Recording Tips** A broadcast quality microphone and a good quality cassette machine or computer will be a great asset in producing high quality programs to use on the air. Usually, it is best not to use automatic gain control since it tends to quickly bring up background noises or produces a "hiss" during pauses in speech.

**Tape/CD Labeling** Please do! Every tape/CD should be labeled with the name of the program, and either the program number or the date of the program's release clearly marked on the label. One label should be affixed directly to the tape or CD, and one affixed to the outside of the box. TIP You

might consider using a year/week numbering system. For example: the first week of 2007 can be numbered 0701, the second week - 0702 etc. Number each week this way on your calendar and you will have it "at a glance." Alternately, you could use a year/month/day format like this: 070101. If you are using mp3 files your filename would look like this: TFM0701 or TFM070101. (TFM for Teaching Faithful Men – abbreviate your program name)

**Scheduling** We welcome broadcasters to indicate when they desire the broadcast to be played. In the absence of a written schedule or a date, we will use our own judgment as to which program to air when. Please, clearly mark programs that are seasonal - relevant only to a certain date or season such as Christmas, Easter, etc.

**Library Supply** A supply of reserve tapes/CDs for each program will be kept in the station's library, to be used for broadcast in emergency situations when regular current programs do not reach the station on time for whatever reason.

**Tape Mailing** If possible, cassette tapes/CD's should be sent in padded envelopes with the small green customs label affixed, indicating the contents as "Religious recording tape" Mark the package "A.O. - AIRMAIL." (Small Packet) and Address it to:

*Tapes should not be sent via surface mail due to the extensive delay in transit.*

**Invoicing** The Harbour Light does not invoice for air time. We believe that the Lord will enable you to support your program on the

Harbour Light in some way. Why not prayerfully consider a monthly donation claiming the Lord's promise in Phil. 4:19 as if it were true? (It is!) Be it unto you according to your faith!

**Returns** We will not be able to return tapes/CDs to broadcasters unless special arrangements are made. Make sure you keep the masters!

**Donations** All donations should be by check or money order (if possible) and made out to the Harbour Light of the Windwards. Each gift will be acknowledged.

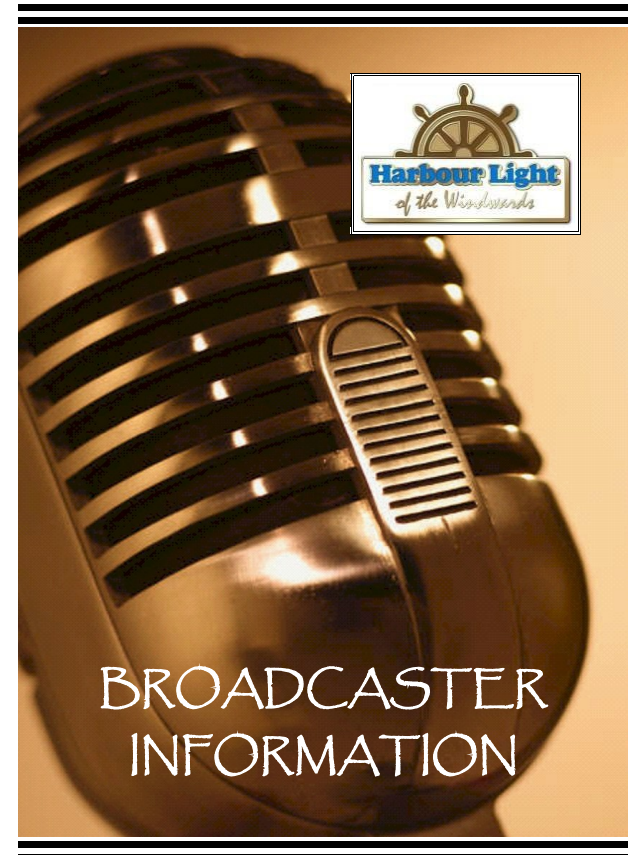
